At **Ennis Regional Medical Center**, we spent 2016 exploring ways to advance our mission of making the communities of Ellis County and surrounding areas healthier. And by focusing our efforts on creating a place where people choose to come for healthcare, physicians want to practice and employees want to work, our more than 100-year legacy of caring for our communities is stronger than ever.

**Inviting the best physicians into our communities and supporting them** is one of the most important drivers of our ability to offer the best possible healthcare to the region. During the past year, Ennis Regional added **20 new providers** to our staff in emergency medicine, family medicine, hematology/oncology, anesthesiology, podiatry, hospitalist services, surgical services and physical medicine and rehabilitation.

And while **delivering high quality patient care close to home** is the single most important contribution we make, there are many other ways we're making a positive impact in our communities.

In **creating excellent workplaces for our 170 employees**, we made **\$755,637 in capital improvements** in 2016, including new patient beds and surgical equipment and a telemetry software upgrade; and we managed and distributed an **annual payroll of \$10,125,954**.

We are proud to take a **leadership role in our communities** and are committed to delivering needed healthcare to everyone, regardless of their ability to pay. In fact, in 2016 we donated **more than \$3 million in healthcare services to those in need**.
